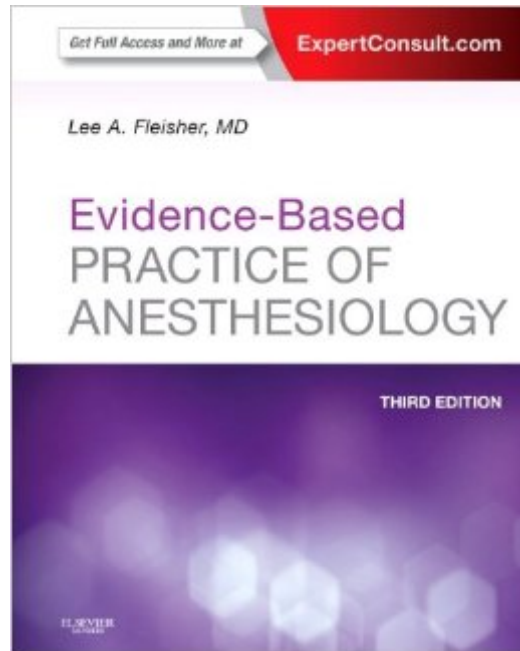

Like much of science, the anesthesia literature is often incomplete and contradictory. Still, scientifically oriented anesthesiologists will be delighted.
